MA & ME legalized marijuana. We don't know what impact it will have on NH. Opioid rules are coming together. NH Board of Medicine enforcement authority is just on a complaint basis.

Tom Sherman did not get elected for Senate.

Single payer group would like to hear your patients' experiences- struggling with insurance or lack of.

An IMG would like to meet and understand what the chapter does. Her story is not unfamiliar to women- came here with family and raised her children thinking she will get around to her own career.
